**RE: Shared-Ride Program**

Dear Senior Applicant:

CCT Connect is a door-to-door transportation service for senior citizens 65 years of age and older. This Shared-Ride Program, sponsored by the Commonwealth of Pennsylvania and administered by SEPTA's Customized Community Transportation Department, is offered on a first-come, first-served, space available basis to residents of the City of Philadelphia. Eligible seniors may travel throughout the City and anywhere in Bucks, Delaware and Montgomery Counties within three miles of the City's border. Seniors age 65 and over pay 15% of the fare, and the lottery fund pays the remaining 85%.

To register for this service, you must complete the enclosed registration form and return it to SEPTA CCT Connect, along with a copy of a document that verifies your age. Only the following documents will be accepted for age verification:

- Birth Certificate
- Baptismal Certificate
- Valid Driver's License
- Pennsylvania Non-Driver's License
- Armed Forces Discharge Papers
- Statement of Age Verification from the Social Security Administration 1-800-772-1213
- PACE Card
- Valid Passport or Naturalization Papers
- Veteran's Universal Access ID Card

Please return your completed registration form, along with verification of your date of birth, to SEPTA CCT Connect at the address below. Remember, you must live in the City of Philadelphia and be at least 65 years old to qualify for the Shared-Ride Program in Philadelphia.
